



## TAKE THESE SIMPLE STEPS TO AVOID FALLS THAT CAN KEEP YOU OUT OF WORK.

Falls from construction equipment cause serious injuries to operators and service people. The larger the equipment, the greater the fall distance and the more severe the injuries.

### WHY FALLS OCCUR:

- **Poor housekeeping.** Many falls occur because of poor housekeeping. Oil, mud and grease accumulate on the equipment. Also, in cold weather, frost, ice and snow can build up on the equipment to create slippery surfaces.
- **Failure to use steps and ladders.** Steps, ladders and grab bars are installed on most new equipment. They are there for your safety and should be used for mounting or for dismounting. Checking an engine and other servicing locations can be difficult. The job can be done more quickly and more safely using a stepladder, so take the time to locate and use one.

## PREVENTING FALLS FROM CONSTRUCTION EQUIPMENT

### 8 STEPS TO SAFETY

1. When climbing on the equipment, use the hand and step holds.
2. Avoid doing the “split” to make long reaches.
3. Avoid carrying packages or tools when mounting or dismounting.
4. Wear appropriate footwear.
5. Never jump from the equipment.
6. Report any damaged handholds or footholds so they can be repaired.
7. Advise the master mechanic if the machine needs additional rails or steps.
8. Keep your machine free of leaks; clean off mud, ice, snow, grease and oil that can make surfaces slippery.
